SONDRA KELLY AWARD

The Sondra Kelly Award provides \$5,000 to a woman screenwriter in mid-career for research/development on a self-initiated project.

Sondra Kelly was a longtime member of the Writers Guild of Canada. In 2007, she received the WGC Writers Block Award for her record of exceptional service to the WGC and for strengthening the Canadian screenwriting community as a whole. In addition to serving on the WGC Council from January 1997 to December 2003, Sondra occupied the first WGC-designated seat on the Actra Fraternal Benefit Society (AFBS) board (1998-2003). Hers was the first writer's voice on a board made up of actors, producers, and broadcasters at a time when a writer's voice was much needed.

This award in her memory, generously supported by the AFBS, honours her dedication and contribution. Join us in celebrating Sondra's life and achievements through this award.

To be eligible, a candidate must:

- Be a woman and a screenwriter in mid-career
- Have several produced writing credits
- Be a WGC member in good standing

A jury of peers will select the recipient of the award. Please note that only the person chosen to receive the Sondra Kelly Award will be contacted. The recipient will be announced at the 24th annual WGC Screenwriting Awards on April 27th, 2020, and her name will be posted on the WGC website in May 2020.
