**Letter of Adherence for Animation Productions for Producers**  
**Other Than Regular or Trainee Members of the APFTQ**

Prior to contracting a Writer or Story Editor a Producer who is not a regular or trainee member of the APFTQ shall sign a Letter of Adherence as follows on its own letterhead and forward it to the Guild. This Letter of Adherence shall constitute a binding obligation by the Producer to the terms and conditions of the Animation Section of the Independent Production Agreement where such independent Producer is involved in the production of a program:
